OFRF monitors research needs and evaluates how best to meet those needs. OFRF awards grants annually to research projects that address the technical, real world challenges faced by organic farmers. OFRF publishes and disseminates research results free-of-charge to all organic farmers in the U.S. and others interested in organic farming research.

OFRF s advocates for the needs of organic farmers and works to ensure they have equal access to federal agricultural programs and services. OFRF works to engage organic farmers directly in efforts to educate policy makers about organic farming. OFRF analyzes public policies for their impact on organic farming, and works to develop infrastructure to support the success and adoption of organic farming practices.
