Research and Education: OFRF works to increase the quality and quantity of organic research and education to meet the needs of organic farmers in the field. OFRF monitors research needs and evaluates how best to meet those needs. OFRF awards grants annually to research projects that address the technical, real world challenges faced by organic farmers. OFRF publishes and disseminates research results free-of-charge to all organic farmers in the U.S. and others interested in organic farming research.

4b (Code:) (Expenses \$ **122,162** including grants of \$) (Revenue \$)

Policy: OFRF's advocates for the needs of organic farmers and works to ensure they have equal access to federal agricultural programs and services. OFRF works to engage organic farmers directly in efforts to educate policy makers about organic farming. OFRF continues to build an organic farmers actions network (OFAN), adding approximately 200 growers annually. OFRF analyzes public policies for their impact on organic farming, and works to develop infrastructure to support the success and adoption of organic farming practices.

Communications: OFRF's communications program works to make the findings and implications of agricultural resources accessible and relevant to organic farmers. Organic Farming Research Foundation procedure for monitoring the use of grant funds in the United States. OFRF has a multilevel process to ensure that grants funds are spent appropriately.

I. Competitive selection process. OFRF uses a competitive process to identify high quality organic research and education projects to fund. The request for proposals mandates that applicants thoroughly explain their scientific methodology including the experimental design, and contains explicit language about what kinds of costs can and cannot be included in proposal budgets.

II. Committee Review. Each proposal is carefully scrutinized by a panel of 7 board members with expertise in organic farming, research and marketing. The criteria used to assess proposals include use of a scientifically sound methodology. An important part of the review process involves ensuring that project methods are valid and that budget line items are reasonable and fit within the funding requirements.
